VI INTERNATIONAL CHILDREN'S CONTEST OF FINE ART "WAVE ON WAVE - 2020" REGULATIONS

I. GENERAL PROVISIONS

- 1. Regulations of The International Children's Contest of Fine Art "WAVE ON WAVE 2020" regulates the purposes, tasks and organization of the contest.
 - 2. The initiator and organizer is Klaipėda Adomas Brakas Art School.
 - 3. The contest is dedicated to cherish nature, art and culture.
 - 4. Sponsors: Education Department of Klaipėda City Municipality Administration.

II. PURPOSE AND TASKS

- 5. The contest is to develop a creative student who wants to take interest in his country's living nature, endangered species of plants, mammals, insects and other animals, cultural heritage, to cultivate respect for the living nature and ethnic cultural traditions, to develop children's creative and artistic skills.
 - 6. Theme: "Nature's Code Preservation":
 - 6.1. Endangered species and their environment in my homeland.
 - 6.2. Living nature in folk art of my country.
 - 7. Tasks of the contest:
 - 7.1. to educate children's creative and cooperation skills;
 - 7.2. to motivate children's self-expression and creativity.

III. ORGANIZING THE CONTEST

- 8. The contest is open to students at age of 6 to 19.
- 9. Participants from one school can deliver up to 10 works.
- 10. The participant can submit 1 work created on the chosen technique:
- 10.1. drawing, graphics, painting, collage (the maximum format is A2);
- 10.2. sculpture, ceramics (up to 50 cm height).
- 11. Works must be delivered physically to Klaipėda by 24 April 2020. Delivery address: Klaipėda Adomas Brakas Art School, Paryžiaus Komunos street 12, LT- 91166, Klaipėda, Lithuania.
 - 12. The winning works will be exhibited from 9 June 2020 by 31 September 2020.
 - 13. The following requirements apply to participating works:
 - 13.1. along with the works you must provide a list of participants;
 - 13.2. on the back side of the work must be labelled work identification label (attachment
- No.1, No.2). Work identification label also must be sent to the following e-mail: s.mingeliene@brakas.lt;
- 13.3. works which will be submitted after the deadline or will not have a work identification label will not be evaluated.

- 15. The winners will be awarded at the final event of the contest and the opening of the exhibition on 11 June 2020 at Klaipėda Adomas Brakas Art School.

- 17. The jury selects 3 best entries for each age group and individual nominations according to the technique:
 - 17.1. I group -6 10 years;
 - 17.2. II group 11- 15 years;
 - 17.3. III group -16 19 years.
 - 18. Works will be evaluated by a jury formed by the organizers.
 - 19. Work evaluation criteria:
 - 19.1. perception and disclosure of the theme;
 - 19.2. originality of the idea;
 - 19.3. artistic expression;
 - 19.4. work completeness, artistry;
 - 19.5. original use of the chosen technique.
- 20. Winners and their teachers will be awarded with diplomas, letters of thanks and commemorative gifts.

V. FINAL PROVISIONS

- 21. Works will not be sent back to the authors.
- 22. After the contest and exhibition, works can be taken back from October 1st to 31st from the sent address. Works will not be stored after this date.
- 23. The organizers reserve the right to publish and reproduce the works at their own discretion without paying any fees. Participation in this contest is the authors' consent to these terms.
- 24. The organizer reserves the right to change and supplement the regulations during the contest.
